NETHERLANDS VISA REQUIREMENT

Passport : original passport must not be older than 10 years; also, it must be valid for at least three months longer than the intended stay. Your passport must have at least two blank pages to affix the visa. Passports with observations regarding the front data page cannot be accepted.

Application Form and declaration form: To be filled & signed by applicant. (Children below 18 age: visa application has to signed by both parents)

Photographs: Two recent photographs in the size of 3.5 cm x 4.5 cm with white background. The face should cover about 70-75% of the photo area.

Cover Letter: Original covering letter from the Applicant mentioning name, address Nationality, Passport no, the purpose of visit overseas along with the duration, the date of travel and about expenses during visit. Letter should be address To: The Visa Officer, The Embassy of Netherlands, New Delhi. Please find the attached covering letter. If self employed then cover letter should be on company letter head.

Personal Financial Documents:

- Original Updated Bank Statements for the last 3 months duly stamped and signed by the bank; (internet bank statement will not do).
- Latest Income Tax papers for the last 3 years or Latest Three years - Form 16A last
- Company Registration/Proof of profession : If Self Employed (Director/Proprietor/Freelancer/Doctor)

Proof of Employment if Salaried:

- No objection certification from the organization confirming the leave status stating your position and the length of your service & Pay slip of last three months.

If Sponsor: ITR Last Three years and Latest 3 months Bank Statement with Sponsor letter and Signature ID Proof. (Eg: Passport copy /Pan Card Copy)

Student: School Id/ Bonafide Certificate

Processing Time: The time required to process Visa Applications is minimum of 15-20 working days for Mumbai (depend on case to case.)

Notice: New application procedures from 02 November 2015

Applicants applying from 02 November 2015 for a Schengen visa will need to appear in person in order to provide biometric data (fingerprints and photograph).

Schengen visa is valid for

Austria, Belgium, Denmark, Finland, France, Germany, Greece, Iceland, Italy, Luxembourg, **Netherlands**, Norway, Portugal, Spain, Sweden, Poland, Latvia, Czech Republic, Lithuania, Slovakia, Hungary, Malta, Slovenia, Estonia, Switzerland, Lichtenstein

NOTE: All above requirements are compulsory in order to process the case. Any applicant can be requested to provide more documents or to go through an interview. Non adherence will render the application liable to rejection. Visa application has to submit in VFS.

Disclaimer: It must be noted that grant or refusal of a visa is at the sole discretion of the Embassy.
