VISA REQUIREMENT

Requirement for PAR (Pre-Arrival Registration) for Hong Kong:

Step 1 : Kindly fill up and submit the appended google Form Link (from your personal Gmail id) for Hong Kong PAR. **https://forms.gle/ZvczoqccpzYJuQFo8**

Step 2: Once the PAR is approved, we will share the same with you. Kindly carry a physical copy of the same along with your other travel documents.

Step 3 : In case PAR is rejected, we need to apply for Hong Kong E-Visa which usually take 3 to 4 weeks. The E-Visa Fee will be approx. HK \$230 - 250 per Visa.

Required documents to apply E-visa are: (Processing time: 3 to 4 weeks)
